- 2. All shelves inside the cupboards and dispensing counters should be white painted and also all external wood work wherever this is considered necessary.
- 3. Procure external use and poison labels as prescribed in this office letter No. 708 of 23rd September, 1929.
- 4. If possible to place marble top on dispensing counter.

# Laboratory:

- 1. Two sets of shelves each la x 2 metres should be fitted in this section, vide No.17(e) of Special Conditions.
- 2. The existing table to be made into two, one of which to be fitted with a marble top for dispensing.
- 3. Mo.5 b & c of Special Conditions in respect of the washing arrangement.




